

# **PPAN** Roadmap

European Strategy for Particle Physics Update

#### **STFC PPAN Roadmap**

- During 2024 SB is developing a long-term prioritised PPAN Roadmap
- The key goals of PPAN Roadmap are:
  - Define a balanced programme of excellent science across PPAN research areas over a 10-year timeframe, within a realistic financial planning envelope
  - Balance physics exploitation, maintenance and operations, R&D, construction projects etc
  - Balance of small/medium/large projects
  - Support for studentships, fellowships and skills pipeline
  - Support for interdisciplinarity and cross cutting themes.
- Aim to complete the process by early 2025

Roadmap Questions" (also, next slide) by 28 August 2024

#### **PPAN Roadmap Questions**

- 1) Have there been any significant changes or developments that would cause the panel to alter the recommendations in their current roadmap?
- 2) Have there been any major scientific developments within the field since the roadmap was last updated that should affect STFC's consideration of future support of relevant UK research?
- 3) Where applicable, have there been any significant updates to relevant international roadmaps?
- 4) Have any significant new opportunities or risks emerged for the health of discipline that are not included in the current roadmap, or that need to be expanded upon in more detail?
- 5) Do any of the recommendations in the roadmap require a significant update or revision?
- 6) What do you consider to be your key skills gaps that need addressing?
- 7) Are there any trends across skills needs (for example, regional, career stage) that are notable within your particular area?
- 8) What do you anticipate will be the future skills needs?
- 9) What are the key strengths, weaknesses, opportunities and threats for your science area currently, and looking across the next 10 years

## **Structure of the meeting**

- Forward-looking, high-level reviews of science areas and projects. Focus on future of the field and UK community plans/strategy
- Presentation and discussion of Community Survey results
- Discussion session on Wednesday afternoon structured around survey results, PPAN Roadmap Questions and process.
- Overview of plans and discussion on UK input to European Strategy for Particle Physics Update (ESPPU).

# **Goals of the meeting**

- Collect and digest Community's view on near-, mid-, and long-term future of UK PP programme
- Obtain input from the Community to answer <u>9 PPAN Roadmap questions</u>
- Collect and summarise input on recent changes in STFC governance, advisory structures, Roadmap process.
- Inform and engage community with ESPPU.
- Following Community Meeting<sup>\*</sup>,
  - PPAP will prepare answers and update summary of survey results July
  - Will make answers and summaries available to community for comments Jul-Aug
  - Submit final answers to SB PPAN by 28 Aug.
